- 1. Welcome: At 5:33 Cheri welcomed everyone, introductions were made and consensus process reviewed.
- 2. Review: Consensus to approve April 12, 2017 meeting minutes.
- **3. Member Comments:** Kiya has been talking with Lloyd, local business owner of The Worm Guy. He will start taking our industrial compostable waste. Very exciting! Kiya will be visiting the compost site soon and will write-up an announcement about it.
- 4. Recap of Movie Night; Follow-up Discussion on Food Waste Advocacy and Next Steps:
 - Everyone was pleased with the turnout and the conversations that were had. A good cross section of ages were present. We made \$50 from 10 non-members that attended. It cost \$315 to host the showing, minus the \$50 that we made. Nic has a budget for 3 movie nights. The group consensus is to keep move nights free for members. The Nominating committee requested the next movie night be on October 2 at Richards Goat again. It will be an opportunity to meet the candidates and watch a movie.
 - Colin mentioned showing *Food For Change*. We might consider checking in with Zero Waste Humboldt to see if our showings conflict with any of theirs.

- Cheri mentioned inviting David Thompson, narrator of *Food For Change*, to come to the showing. Cheri said she could try to track David Thompson down once Nic confirms we can show *Food For Change*. Following the October showing we should plan a January or February showing.
- The group would like to plan for the next showing to have an action that people can get involved with following the showing (i.e. signing political postcards, etc.). There should also be sign-up sheets to get on different committee email lists and outreach to get out the vote for the co-op elections.
