# September Board Meeting Recap: Progress Toward Improving the Triple Bottom Line

Two of the board's biggest decisions at the September meeting reflect our commitment to "triple bottom line" management; that is, ensuring that our operations continue to have a positive impact on our environment and our community while maintaining financial sustainability.

Eureka Deli Expansion Plans Move Ahead—with the Triple Bottom Line in Mind

Co-op managers have been working with consultants over the last year to develop concepts and plans for an expansion of the Eureka deli and a corresponding "re-set" of the rest of the store. There was vigorous discussion at the meeting about the project's potential impacts on various measures of the Co-op's financial, environmental, and community success. In the end, the board voted to approve "Phase 1" of the project (development of more specific architectural and financial plans and schedules), while stipulating that the project must have zero net environmental impact and that management should consider providing a more community-friendly eating area in the new store design.

New Pilot "Co-op Access Program" Will Begin Next Fiscal Year After more than a year of development by the Member Action Committee, followed by feasibility review by an ad hoc committee of board members and staff, the board approved a new pilot Co-op Access Program (CAP). The goal of the CAP is: "To help all interested members of the community to access the benefits of Co-op membership and of shopping at the Co-op, including the benefits of access to healthy food and of democratic member ownership, regardless of income." The CAP will offer a 10% discount on all purchases up to \$500/month to members with low incomes. as demonstrated by their participation in the CalFresh (formerly food stamps), WIC and/or SSI programs. The pilot program will run for one fiscal year starting at the end of March 2017 and will be limited to 50 participants, after which the board and management will assess the CAP's success at achieving its goals and the impacts on

the Co-op's finances.

## ...and (as usual) much more!

The board also approved updates to our elections policies, approved a newsletter policy and a policy for keeping our membership rolls and share accounting up to date, set a 2% C-share dividend rate for the coming fiscal quarter, and directed the General Manager to being providing us with annual business plans and marketing plans to review each fiscal year, among other decisions. If you want more details, the full minutes of the meeting will be included in the board's October meeting packet. You can get a copy of the board packet at the customer service desk (or by email if you request it) about a week before that meeting.

Next board meeting is the Annual Membership Meeting on 10/22, 3pm at Azalea Hall.

ber-owners to address the board and fellow attendees.

Dinner will be served at **4:45**; a baked potato bar with toppings, a green salad and dessert will be provided. During the Meet & Greet and dinner portions of the event we have invited Co-op member-owner Howdy Emerson to share his gift of Celtic Harp music for all to enjoy. We encourage all attendees to bring their own reusable tableware (plate, cup, silverware, etc.) plus to-go containers to take home leftovers.

There will be time for further visiting at the discussion tables following dinner before the meeting adjourns at **6:00**.

# **Homemade Chicken Stock**

Soup. It can often be the quickest answer to a hungry belly and a simple method for packing a whole lot of nutrition into a one-pot meal. When it comes to nutrition, quality and cost, you have to be making soup at home. Simple ingredients and fresh herbs are all you need to create a magnificently rich and golden stock to use for any number of soups. Stock by definition is water is which aromatics, veggies and bones are simmered and strained and simmered again to condense the flavors. Broth is stock mixed with additional water, veggies and aromatics. There are lots of benefits to making your own stock; the most valuable being cost savings. Whether you are choosing to purchase our organic rotisserie chicken or roasting your own, using the remaining bones is cost effective and waste conscious. Save your veggie scraps (the ends of carrots, celery and onions can be tossed in a bag in the freezer until it is soup stock making day) and you can save even more!

# **Ingredients:**

Leftover chicken bones\*

- 1 tablespoon apple cider vinegar
- 2 stalks of celery with leaves, coarsely chopped
- 2 large carrots, peeled and halved 1 white onion, guartered
- 1 bay leaf6 black peppercorns
- \*Omit the chicken bones and double the veggies for a simple veggie stock.

# **Directions:**

- **1.** Bring 2 quarts of water to boil in your largest soup pot.
- **2.** Add bones, celery, carrots, onion, garlic, peppercorns and bay leaf.
- **3**. Bring covered pot to a low simmer for 2 hours.
- **4.** Uncover and skim any foam that has accumulated and increase heat to medium simmer for another 2-3 hours.
- **5.** Once the liquid has reduced by

- half, strain through a fine mesh strainer and/or cheese cloth.
- **6.** Kept in the fridge, your stock will last up to 5 days.
- **7.** Additionally, you can fill ice cube trays and freeze it. Once frozen, store in air tight container or Ziploc bag, and they will last up to 6 months. (One standard ice cube equals 2 Tablespoons)

# The Driscoll's Boycott is Over

We are thrilled to share that the Driscoll's berry boycott is over. On September 4, we received word from Familias Unidas por la Justicia

(FUJ) that they had "officially agreed to an election and negotiation process for a collective bargaining agreement with Sakuma Bros. Berry Farm."

North Coast Co-op was one of dozens of retailers across multiple states participating in a boycott of Driscoll's berries and select Haagen-Dazs berry flavors in solidarity with FUJ, a worker's union calling for better labor practices at Sakuma Bros. Berry Farms in Skagit Valley, Washington. Driscoll's and Haagen-Dazs are Sakuma's largest accounts.

FUJ President Ramon Torres asks that "out of respect for the process and our memorandum of understanding with the company please do not contact past, present or potential customers, purchasers, sellers or users of products coming from Sakuma Bros. Berry Farm to convey criticism of any and all aspects of Sakuma's business and operations."

This next phase of the union's development comes after years of attempted negotiations for better working conditions. According to FUJ's website, FUJ is the second independent farmworker union to form in Washington in 30 years and is the first union led by indigenous workers. Until a secret ballot election on September 12, 2016, Sakuma Bros. refused to recognize FUJ as a legitimate union. Torres says, "this win is a win for all farmworkers," and

hopes that it will usher in a new era for farmworker justice in Washington State.

A growing number of Humboldt County farmers now accept CalFresh, formerly known as food stamps, directly at their farms! Use your EBT card to purchase Community Supported Agriculture (CSA)\* shares and/or shop for produce at farm stands at the locations shown to the right.

# \* Purchasing a CSA Share with EBT:

Community Supported Agriculture (CSA) is a partnership between a farm and a community of supporters. CSA members commit to a farm for a whole growing season by purchasing a CSA share. The farmer then provides each member with a weekly distribution of fresh, seasonal produce at the peak of ripeness and nutrition. Talk to the farmer about CalFresh payment options.

# 30th Annual Co-op **Pumpkin Patch**

his year, North Coast Co-op celebrates ■ 30 years of providing school children across our county with an educational field trip to a working farm during the North Coast Co-op Pumpkin Patch event. Over the course of two weeks, approximately 4,000 students, along with teachers and parents will travel to Warren Creek Farms in the Arcata Bottoms where they will learn about local agriculture, pollination and dry farming. After some time exploring the pumpkin patch and learning organic farming, each child gets to choose their own pumpkin to take home, provided by North Coast Co-op's Cooperative Community Fund.

This year's educational theme is the water cycle. Co-op staff and volunteers will educate students on how the water cycle works, and will focus on the unique location of Warren Creek Farm, the Mad River and the history of the area before and after the 1964 flood.

The pumpkin patch and Warren Creek Farm's farm stand is located at 1171 Mad River Road, in the Arcata Bottoms. School reservations have already been made for this year and our Pumpkin Patch event is full. However, the pumpkin patch is open to the public, so you and your family and friends can visit the farm and have your very own pumpkin patch experience.

There are over 25 varieties of pumpkins growing, from the tiny Wee-B-Little pumpkins to the classic Howdens, to the lumpy Knuckle Heads, to the bright red-orange Cinderellas. Travel through the corn maze and out into the pumpkin patch to choose your own pumpkin, or just drop into the farm stand to choose from prepicked pumpkins, squash, beans and potatoes fresh from the farm. Be sure to take in the breeze, the pastures and the towering sunflowers while you are there.

# Visit the Warren Creek Farm Pumpkin Patch

Directions to the Patch: Take the Giuntoli Lane exit off of US Highway 101. Go west and take the frontage road (Heindon Road) to Miller Lane to Mad River Road. Follow the signs towards Mad River Beach. Warren Creek is the first ranch on the right past the old Canal School. For more information, call Warren Creek Farm at 822-6017.

# Starting the Fiscal Year Strong

The first quarter of Fiscal Year 2017 ended with sales of \$8,935,872. The Arcata store sales were 6% above last year's sales and the Eureka store exceeded last year's sales by 3.2%. Total revenue for the first quarter exceeded projected budget by 5%. In summary, our combined quarterly store sales are higher than projected by \$395,627. Expenses increased over budget by \$237,158 due to the cost of increased sales. First quarter reflected a net profit of \$132,747 in comparison to last year's first quarter profit of \$68,739.

Hope everyone will join us at the Annual Membership Meeting on October 22. It's always a great event, with exceptional food.

The Co-op Community Fund's grant cycle started September 1 with guidelines available online at: northcoast.coop/good\_stuff\_we\_do/cooperative\_community\_fund/. Local area non-profits that have projects focused on the following areas are highly encouraged to apply:

- Sustainable Agriculture
- Food Security (defined as access to a safe supply of quality food to all aspects of a community)
- Food Nutrition and Education

Grants will range from \$500-\$2,000 with exceptions possible on a case-by-case basis. Applications are due November 1. Last year the Co-op Community Fund awarded \$18,900 to 21 non-profits for their projects.
